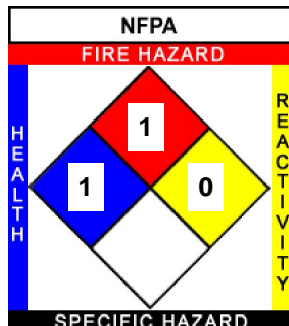

### FIRST AID MEASURES
